Proceeding of the meeting of Purchase and Sales Committee, JUT, Ranchi regarding E-Tender (published vide Tender no. JUT/45/2018/775, dated 20/09/2019) for Printing and Supply of Bar Coded Answer Books (with OMR sheet as Cover Page) for Examinations conducted by Jharkhand University of Technology (JUT), Jharkhand, held under the Chairmanship of the Vice-Chancellor on 18th October 2019, at 5:00 PM, in the Conference Hall of JUT, Ranchi.

Meeting of Purchase and Sales Committee, JUT, Ranchi regarding E-Tender (published vide Tender no. JUT/45/2018/775, dated 20/09/2019) for Printing and Supply of Bar Coded Answer Books (with OMR sheet as Cover Page) for Examinations conducted by Jharkhand University of Technology (JUT), Jharkhand was held under Chairmanship of the Vice-Chancellor, Jharkhand University of Technology, Ranchi on 18th October 2019 at 5:00 PM, in the conference hall of the JUT. At the outset the Vice-Chancellor extended warm welcome to all the members present in the meeting. Thereafter, the General bids have been opened and after the perusal of the documents which are received through E-tender, then following decisions have been taken:

1. Only Two bidders participated in E-tender and uploaded & submitted their concerned documents. The details of bidders are given below:
 - a. M/s Hitech Print Systems Ltd., Plot no. 07, Industrial Estate, Pedaavutapalli, Dist- Krishna, Andhra Pradesh, Pin-521286.
 - b. M/s Gemini Graphics Pvt. Ltd., 44/45, Naubad Industrial Area, Bidar, Karnataka, Pin-585402.
2. According to provision contained under the Clause no. 4 (i) of this tender, the Technical Bids of only the bidders, short listed from the General bid, will be opened. Also according to the Clause 3.2 (xxii) the Bidder should furnish the details of the address of the Bidder's Country Office / Local Office in Jharkhand. In the light of the said fact and after the perusal of the documents of General Bids, it has been found that the local office of the said Bidders are not in Jharkhand.
3. After the thread bread discussion it has been resolved that only two bidders have participated and it does not seem appropriate to further evaluate the bids as the received two bids are not competitive.
4. According to provisions contained under the Clause no. 4 (v, xiii & xv), Jharkhand University of Technology, Ranchi has reserved the right to cancel / abrogate the whole or a part of this tender documents or withdraw the tender notice without assigning any reason. In the light of the above, further it has also been resolved that not to open the Financial Bid and EMD of demand Draft Rs.100,000/- (One Lakh only) of the said bidders should be returned to them. Again re-tender should be published through E-Tender.
