#### GENERAL CONDITIONS FOR TEACHING & NON-TEACHING POSTS

#### Section-A

- 1. The prescribed essential qualifications and experience are the minimum as laid down in **Section 'B'** of this advertisement.
- 2. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for being called for test/interview. More stringent criteria may be applied for short-listing the candidates to be called for test/ interview.
- 3. The University may conduct examination/seminar/presentation/written test/computer test as a method for further shortlisting of candidates for interview as decided by the competentauthority.
- 4. Those already employed should apply through proper channel (The candidate(s) employed in Govt. Organization/ PSUs; Autonomous Bodies should send the copy of application along with relevant document of the employer through their offices).
- 5. The envelope should be superscribed with the name of the post, advertisement number and date.
- 6. Employee appointed on contractual basis will have no right to claim absorption on regular post.
- 7. The University reserves the right to:
  - i. Offer a post at a level lower than that applied for, depending upon the qualifications, experience and performance of the candidate.
  - ii. Draw panel(s) for future appointment(s) in the event of occurrence of a vacancy caused by non-joining of candidate(s) within the stipulated time or where a candidate joins but resignsor dies within a period of a year from the date of joining;
  - iii. Modify/withdraw/cancel any communication made to the candidate(s) at any stage without assigning any reason;
