For preparing the draft of Affiliation Rule & Admission Rule a committee was formed under the chairmanship of Registrar, JUT, Ranchi vide Office order no DTE Sec1/ताशिमप्रविधि - 20 / 2020 / HTESD - 816 Dated 14.09.2022 of Department of Higher & Technical Education, Jharkhand (Annexure-01). In the light of the said letter Affiliation Rule & Admission Rule have been prepared by the said committee. The draft of Affiliation Rule (Annexure- 02) & Admission Rule (Annexure 03) is placed before the Honorable members of the Executive Council for kind approval.	After detailed discussion the members suggested to make following changes:- Affiliation Rules 1. In point no 3.2.1.1, Academic sessions should be replaced as academic years. Admission Rules 1. For B.E./B.Tech admission in point no. 2.B, the Department of Higher & Technical Education, Govt. of Jharkhand should be replaced with Jharkhand University of Technology, Ranchi. 2. For B.E./B.Tech (Lateral Entry) in point no. 2.B, the Department of Higher & Technical Education, Govt. of Jharkhand should be replaced with Jharkhand University of Technology, Ranchi. The Affiliation & Admission Rule was approved by members subject to above changes. It was also recommended to send the copy of the same to Department of Higher & Technical Education, Ranchi after incorporating the above recommendations.


