



# ACADEMIC AND RESEARCH COLLABORATION Between Amity University Jharkhand (AUJ), Ranchi & Jharkhand University of Technology

(Ref: AUJ/02/Reg./MOU/Q-8/919)

This Collaboration is entered into on the 6th day of December 2023 by and between Amity University Jharkhand (AUJ), at HEC Core Capital Area, Near Railway Crossing, Pundag, Ranchi, Jharkhand – 835303 and Jharkhand University of Technology (JUT), Science & Technology Campus, at Sirkha Toli, Kali Nagar, Namkum, Ranchi, Barganwa, Jharkhand 834010. The aforesaid institutions are hereinafter referred to individually as university and collectively as universities.

# 1. Objectives of the Collaboration

- a) To promote and enhance academic interest between AUJ Ranchi & JUT, Ranchi.
- b) To provide advice for implementation of quality of education, Research & Innovation at AUJ Ranchi and JUT Ranchi.
- c) To promote research/ continuing education activities between universities.

### 2. Technical Areas of Collaboration

- a) A Continuous Quality Improvement Program jointly organized to improve quality of teaching staff through short-term/long-term certificate courses at AUJ Ranchi & JUT Ranchi.
- b) Provide academic interaction by delivering Special Lectures on topics of relevance to modern Industry in collaborating Universities.
- c) Provide necessary mutual help in Organizing workshops/seminars/conclave/HR summit/conferences and Personality Development Programs for enhancement of skills in respect of Faculty, Staff and Students of both the Universities.
- d) Provide necessary mutual support for formulating Curriculum, establishment of research Labs, Innovation, Incubation cell, Training & Placement and Library etc. at collaborating Universities.
- e) Mutual Usage of academic infrastructure of students and faculty members of collaborating Universities.

- f) To facilitate mutual training programs, joint research projects & publications.
- g) Joint supervision of PG and Ph. D thesis as per collaborating Institutions/ Universities norms.

### 3. Proposed Modes of Collaboration

- a) Cooperation and promotion of education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction as is agreed upon between JUT Ranchi and AUJ Ranchi.

A specific plan will be worked out by the Universities depending upon availability of resources. A specific agreement will be entered into for each activity.

### 4. Terms and Conditions

- a) The cost of development of infrastructure at individual Universities should be borne individually by the collaborating Universities.
- b) For continuing education to teachers and students, the financial arrangements will be made on mutually agreed terms.
- c) For the visits related to advice & consultancy, travel and other expenses of Faculty & Staff shall be reimbursed by AUJ Ranchi on mutually agreed terms.
- d) The faculty members and students of collaborating Universities can use each other's library facility with prior approvals.
- e) Usage of collaborating Universities academic infrastructure can be allowed for limited period subject to its availability, approval of Head of the facility/department and university norms.
- f) Both institutes agree to help, identify, and invite the faculty members and researchers from the other universities to participate in conferences, workshops, and short-term courses.
- g) This Collaboration may be amended, renewed, and terminated by mutual written agreement of the university at any time.
- h) This Collaboration, unless extended by mutual written consent of the universities, shall expire in five (5) years after the effective date specified in the opening paragraph.
- i) Either university shall have the right to terminate this collaboration upon six (06) months prior written notice to the other university.

j) Any disputes arising there by shall be subjected to the jurisdiction of Ranchi.
