Out of Unadjusted amount of Rs 432.48 Lakhs, a sum of Rs 314.25 lakhs were disbursed by SBTE in the years 2014 to 2019 (Institute wise list attached), before the merger of SBTE with JUT. This has been informed to the department vide letter No. JUT/1093 dated 08.07.2023 for resolution of long pending advance given by the then SBTE. Not angible action seems to be taken as yet. 2. The Remaining advance of Rs 1,12,80,000/- disbursed by JUT from Dec. 2018 to Dec. 2021 by the previous administration, a total of Rs. 86,22,622/- have already been adjusted and balance of Rs. 26,57,378/- is under process and would be settled in a few weeks from now.
