2. Powers and duties of the Academic Council:

The Academic Council shall be the Chief academic body of the University and shall:

- (a) subject to the powers conferred by or under this Act on the Vice Chancellor and on the Executive Council, determine and regulate all academic matters concerning the University in accordance with this Act and the Statutes;
- (b) have the powers of superintendence and control over and be responsible for the maintenance of standards of instruction and education including the conduct of post-graduate teaching and the promotion of research work in the University;
- (c) exercise supervision and control over the conduct of teaching in the colleges in such manner as may be prescribed by the Statutes;
- (d) have powers of general control over the Examination Board, and may review the results of University Examinations; and
- (e) exercise such other powers and perform such other duties as may be conferred or imposed upon it by the Statutes.

3. Term of the Members of Academic Council:

The term of office of members, other than the ex-officio members, shall be for a period of three years with effect from the dates of their respective election or nomination and shall include any further period which may elapse between the expiration of the said period of three years and the date of the next succeeding election or nomination, as the case may be, not being an election or nomination to fill up any casual vacancy but such extended period shall not be more than one year;

Provided that any member elected or nominated shall be deemed to vacate office with effect from the date on which he ceases to be a member of the body which elected or nominated him.
