## Tender Document for Hiring of Vehicles on Monthly/ Daily/ Hourly basis for Jharkhand University of Technology, Ranchi

### 1. Eligibility:

- The Tenderers/ Agency should have owned at least ten vehicles and also experience of running vehicles on hiring basis for at least 01 years in PSU/ Government/ Semi Government/ Reputed Private Corporate Organization.
- The Tenderer should have GST Registration, Central Excise/ Custom department for the purpose of Service Tax. If not already registered, proof of application for registration for service tax must be submitted with the condition that registration certificate will be produced before signing the agreement.
- The Annual turnover of the Tenderer/ Bidder should be more than Rs. 10 Lakh in last three financial years (i.e. 2017-18, 2018-19, 2019-20).
- The Tenderer must not be black listed from any agency or organization.

### 2. Documents:

The following self-attested documents must to be submitted along with Tender in sealed envelope.

- GST Registration of the firm.
- Permanent Account Number (PAN).
- Proof of at least 02 years' experience in PSU/ Government Companies/ Other Private Reputed Corporate Organization.
- Notary/ Self affidavit of available vehicles with registration numbers with Tenderer firm/ Agency. Also attach the photocopies of registration numbers as said in affidavit.
- Notary/ Self affidavit regarding supply of vehicles whatsoever in numbers and type as per requirement of JUT, Ranchi will be supplied within 24 hrs.
- At the time of supply, vehicle must be registered under Commercial Registration. (Notary/Self affidavit)
- EMD of Rs 10,000/-.
- The Tenderer must not be black listed from any agency or organization. (Notary/ Self affidavit)

### 3. Earnest Money:

The Agency has to deposit Earnest Money (EMD) of Rs 10,000/- (Rs Ten Thousand only) in the form of D/D in favor of **Jharkhand University of Technology**, payable at **Ranchi**. The earnest money of all unsuccessful Tenderers will be returned as early as possible after the expiry of the period of the bid validity and after issue of the hiring order. No interest will be payable by the University on the Earnest Money Deposit.

### 4. Forfeiture of Earnest Money:

- Earnest Money is liable to be forfeited and bid is liable to be rejected, if the Tenderer withdraws or amends or impairs or derogates from the tender in any respect within the period of validity and/ or after opening the tender.
- When the Tenderer does not deposit the security money after the hiring order is given.
- If the successful bidder fails to provide the vehicle in the prescribed time after the confirmed orders, the University has full right to forfeit the EMD deposited with the University.
- When information/ certificate/ document furnished is found false at any stage.
- When the bid documents have been manipulated or altered which is downloaded from website.

### 5. Performance Bank Guarantee (PBG):

The successful bidder shall have to submit Performance Bank Guarantee (PBG) of Rs. 1,00,000/- (Rs One Lakh only) by way of Bank Guarantee for successful performance during contract period in favor of Jharkhand University of Technology within 30 days of issue of LoI. EMD will be returned on submission of the PBG. It must be noted that conditions related to forfeiture of EMD shall be applicable with PBG.

### 6. Payment:

- Payment of the same vehicle will be done which is being requisitioned for; even when a more expensive vehicle has been provided by the Agency. However, if a less expensive vehicle has been provided by the Agency in place of a more expensive vehicle requisitioned, then the payment for a less expensive will be done.

- (b) Distance will be accounted from the initiation point to the destination. Distance from garage to the initiation point of journey will not be considered. The billing will be done as per called period and it should be submitted by the Tenderer/ Firm. It will be the responsibility of the vehicle's driver to get signed and verified the Challan entries indicating opening kilometer, closing kilometer, distance covered, time from office, places visited, etc.
- (c) Monthly bills shall be submitted in duplicate to the authority specified in contract along with photo copy of logbook duly signed by the Controlling Officer/ duty slip and payment will be processed on monthly basis. Contractor will submit an undertaking along with monthly bills that he will deposit service tax one month prior to the expiry of contract. The last bill will only be processed on showing the receipt of depositing of all previous service tax for this contract.
- (d) All entries in the bill/ log sheet shall be typed/ written legibly in ink. Erasers and over writing are not permitted. It may render such bills liable for rework/ rejection. Agency shall duly attest all cancellations and insertions.
- (e) If a vehicle is hired on Daily basis for whole day by Jharkhand University of Technology, then rent will be paid only when driver will remain with Jharkhand University of Technology for whole day i.e. 07:00 A.M. to 07:00 P.M. and released from Jharkhand University of Technology by authorized person.
- (f) In the condition of any break down of vehicle or fuel problem occurred during hired period and because of such the purpose of hiring is not fulfilled, Jharkhand University of Technology will deduct Rs.100/- per hour for delay.
- (g) Vender must enclose fuel voucher with payment bill. For the vehicle on Daily basis, the bill must accompany the GPS details. Otherwise, payment of bill will not be paid.
- (h) TDS and GST (TDS) charges will be deducted as per rule.

## **7. Termination of Agreement :**

- (a) The Jharkhand University of Technology reserves the right to terminate the agreement at any time without assigning any reason before the expiry of the mentioned period of notice. The Agreement shall come to an end without prejudice to any right or remedy that may be accrued to the concerned parties of this Agreement.
- (b) If any information furnished by the bidder is found to be incorrect or false at any time, the Agreement shall be terminated and the Performance Guarantee shall be liable to forfeited.
- (c) In case the Contractor wants to terminate the Agreement, it shall have to give three calendar month's notice in advance to this effect Jharkhand University of Technology.
- (d) If the Contractor fails to arrange the supply of any or all of the vehicles within the period/s specified in the contract or any extension thereof granted by the university, suitable legal action may be taken by the university to terminate contract.
- (e) If the Contractor fails to perform any other obligation/s under the contract. The contract is liable to terminated.

10. Night Charges will be applicable for those vehicles which will be used after 7 P.M. and that the vehicles which will be sent out of Ranchi district and stayed at destination for government works and returned another day.
11. Vehicles must carry portable fire extinguisher. Vehicles fitted with GPS system will be preferred. The vehicles provided must no run on LPG/ CNG.
12. Vehicles may be used for inter- state travels, if required. Vehicles should be fitted with needed accessories (e.g. fog lights, toeing hook, etc) to drive on State and National highways including during the nights.
13. JUT, Ranchi shall have the right to ask for replacement of vehicles of the agency if not found in proper working condition and/ or change the driver if found incompetent/ disobedient/ misbehaving.
