- d) Demonstrative leadership in organizing National/State level seminars/conference/academic activities.
- e) Demonstrative leadership of handling high and research equipment.

- 1. Minimum Qualification and experience as prescribed by UGC Regulation /A.I.C.T.E Regulation's (as amended up to date).
- 2. Reservation shall be applicable as per the norms of Government of Jharkhand.
- 3. Those already employed should apply through proper channel.
- 4. Age shall be calculated as on the date of interview.

GENERAL CONDITIONS FOR TEACHING POSTS SECTION-B

- 1. The prescribed essential qualifications and experience are the minimum as laid down in **Section** 'A' of this advertisement.
- 2. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for selection. More stringent criteria may be applied for short-listing the candidates for selection.
- 3. The University may conduct examination/seminar/presentation/written test/computer test as a method for further short listing of candidates for interview as decided by the competent authority.
- 4. Those already employed should apply through proper channel (The candidate(s) employed in Govt. Organization/ PSUs; Autonomous Bodies should bring NOC with relevant document of the employer through their offices.)
- 5. Employee appointed on class basis will have no right to claim absorption on regular post.
- 6. The University reserves the right to:
 - i. Offer a post at a level lower than that applied for, depending upon the qualifications, experience and performance of the candidate.
 - ii. Draw panel(s) for future appointment(s) in the event of occurrence of a vacancy caused by non-joining of candidate(s) within the stipulated time or where a candidate joins but resigns or dies within a period of a year from the date of joining.
 - iii. Modify/withdraw/cancel any communication made to the candidate(s) at any stage without assigning any reason.
 - iv. Not to fill up the advertised posts, without assigning any reason.
 - v. Reduce or increase the number of posts.
 - vi. Decide criteria/ procedure for short listing of the candidates.
 - vii. Relax minimum requirements of qualification and/or experience on the recommendation of the Screening/Selection Committee.
 - viii. Extend the date of interview.

In case, it is detected that the documents submitted by the candidate are fake or the candidate has a clandestine antecedents/background and has suppressed the said information, his/her services shall be terminated.
- 10. In case of any dispute/ambiguity that may occur in the process of selection at any stage the University reserve the right to modify/withdraw/cancel any communication made to candidates also decision of the University shall be final.

- 11. Candidates should send self-attested copies of certificates and mark-sheets from 10th Std. onwards in support of their qualifications. originals should not be sent along with the application but these must be produced at the time of interview or when called for.
- 12. The candidates applying under 'persons with Disability' (PWD) Category are required to submit the Disability Certificate issued by the competent authority in the format prescribed by Government of India for this purpose.
- 13. No correspondence/communication shall be entertained from the candidates regarding postal delays and the selection process.
