## Minutes of the Meeting Held on 30<sup>th</sup> Nov., 2023 at 03:00 PM onwards at J.U.T., RANCHI

A meeting was held at conference hall, J.U.T., Ranchi on 30<sup>th</sup> Nov, 2023 to discuss the admission of Working Professionals under Lateral Entry in various Institutions, the following cases were discussed and examined:-

- Case No. - 1.** One application of Sri Binod Kachhap has been forwarded to JUT, in which the applicant has stated that the distance of his place of working (Electric Supply Section, Khunti) to R.T.C. Institute of Technology, Anandi, Ormanjhi, Ranchi is 42 K.M.
- Case No. - 2** One applicant, Mr. Amit Kumar through his e-mail dated 29<sup>th</sup> Nov., 2023 has informed that he could not apply within the deadline for submitting of application. He has requested for extension of deadline so as to provide him opportunity to apply.
- Case No. - 3** One applicant namely Amit Kumar Kashyap who is also presently working in ESD - Khunti has claimed distance of his working place to R.T.C. Institute of Technology, Ormanjhi, Ranchi as 42 K.M. only and in its support he has enclosed a certificate of his Sr. Manager (ESD, Khunti) in which distance is mentioned as 41 K.M.
- Case No. - 4** One applicant Sri Baikunth Rabidas, has also enclosing certificate of his Sr. Manager (ESD - Khunti) mentioning distance of his working place (ESD - Khunti) to Nilai Educational Trust's Group of Institutions, Thakurgaon, Ranchi as 34 K.M. and has requested to consider his candidature.
- Case No. - 5** One applicant Sri Sailesh Kumar Kachhap has same case as Case No. - 4
- Case No. - 6** One applicant Mr. Raj Krishna Kumar has stated in his application that there was typing error in his place of posting and has requested to treat his posting place Ranchi in place of Latehar (as mentioned in earlier application).
- Case No. - 7** One applicant, Mr. Ashok Kumar Tiwary - accepting his age to be 58 years; has submitted that there was no age limit prescribed by AICTE but in the SOP it is given as 55 years. He has further mentioned in his application that for re-employment or self-employment purpose he wanted to get admission in B.Tech program.

Committee went through all the aforesaid applications and finally decided that today is last date of admission as per AICTE notification and the cases were rejected or found under category of "Non-eligibility" previously during joint scrutiny on the basis of notified conditions of SOP. So, at this stage it is not possible to reconsider the cases.
